Mission:	Search & Rescue, Law Enforcement, Boating Safety, & National Ice Rescue School						
AOR:	Saginaw Bay and Saginaw River for SAR. Saginaw Bay is very shallow with several bars extending one to two miles from shore. Due to the shallow water during the winter, ice can be 8" to a couple of feet thick. Fishermen will drive ATVs, snow machines and other motor vehicles several miles from shore. The Saginaw River does have commercial traffic with tanker and bulk stone and gravel carriers around 400-600' in length. The river channel has a marked width of 200', for a total distance of 27 miles.						
Brief History:	The U. S. Coast Guard's presence in the Saginaw River area dates back to 1842 when a light house was constructed on a portion of land ceded to the U.S. Government by the Chippewa Indians. The original light was replaced in 1876 by the Saginaw River Rear Range Light, located about three quarters of a mile from the mouth but still on the west side. Its use as a range light was discontinued in 1964 when the current range light system was put in operation, however; the building continued to serve as the station until December 1980, when the Coast Guard moved to its present location. The old lighthouse still stands today across the river to the north.



In closing, safety always, "Safety" is the key that will keep us out of harms way.




AREA OF RESPONSIBILITY (AOR) – SAGINAW BAY

REPORTING ABOARD THE UNIT

<u>Receiving orders</u>: After receiving orders at Cape May you will be allowed to contact your future duty station. The following is information that the Officer Of The Day (OOD) will need:

- 1. Full Name
- 2. Contact Information
- 3. Leave Address between boot camp and unit
- 4. Size of shoes, clothes
- 5. Report Date

REPORTING ABOARD CONTINUED

Reporting Uniform:

01 MAY – 31 AUG : Tropical Blue (Short) 01 SEP – 30 APR : Dress Blue Bravos (Also bring a complete ODU to change into)

Reporting To Unit: When you arrive, ask for the OOD and have an original copy of your orders in hand. If OOD is unavailable, report to the watch stander in the communications room. We require you to contact the OOD the day before you report. If it is a holiday they will instruct you to report. If during business hours you need to report between 0800 and 1600.
